TERMS AND CONDITIONS

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entrants are only open to Australian residents aged 18 years or over.
- 3. Employees (and their immediate families) of the Promoters, and agencies associated with this promotion are ineligible to enter. - Make a purchase of \$60 or more at Townsville Shopping Centre stores on Friday 28 November before 1pm.
- Present your receipt/s for verification to the Star 106.3 broadcast behind Boost Juice between 10am and 1pm on Friday 28 November 2025.
- All receipts must be for purchases within the promotional period.
- You'll be issued a code to enter into the safe to see if it opens for a prize.
- Unlimited entries with unique receipts.
- 6. The Promoters reserve the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoters have reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
